

Site fee will be \$25 per site. Power will be an additional \$5 per outlet. We ask that you include payment with your application.





MARKET STALL SITE CONDITIONS

- 1. Stall Holders must prominently display their Name & Contact Details on their stall.
- 2. Stall Holders are required to complete setting up their stall prior to 3pm.
- 3. Moving Vehicles will not be permitted in the Market area after 3pm.
- 4. <u>Aurora regulations</u> (as per Electrical Installations Standards AS/NZS 3002) require all power users <u>provide</u> their own safety switch unit (Residual Current Device) on their stall. All stall holders utilizing power must comply with current appliance tagging regulations, appliances must have current tags. It will be necessary for you to ensure all power cables run safely between your connection point and your site to ensure safety for all using the showground.
- Public Liability Insurance All stall holders are required to be covered by Public Liability Insurance. A
 Certificate of Currency must be available for perusal at any time by the Society.
- 6. <u>Temporary Food Premise</u> Any food business attending the Farmers Market must have registration as a 'temporary food premise' or completed 'notification requirements' with Council. Any food stall that has not complied with the registration or notification requirements of the Food Act 2003, will be directed to immediately cease all sale of food and leave the facility.
- 7. Trading Hours: Christmas Twilight Market is open to the public from 3pm until 7pm.
- 8. The Society takes no responsibility for unattended stalls.
- Whilst we will try to accommodate your site preference, final site allocation of stall sites will be at the discretion of the Society.
- 10. Site Payment refunds will not be issued.
